PART I. GENERAL EXPECTATIONS

Athlos Academy of Jefferson Parish agrees to implement the following statutory requirements:

- 8. <u>Athlos Academy of Jefferson Parish</u> will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --
 - the state's academic content standards,
 - the state's student academic achievement standards,
 - the state and local academic assessments including alternate assessments,
 - the requirements of Part A,
 - how to monitor their child's progress, and
 - how to work with educators:

Parents will receive training and necessary information on the topics above through PTO meetings, grade level informational meetings on content standards and standardized tests, and school/district sponsored trainings and workshops.

- 9. <u>Athlos Academy of Jefferson Parish</u> will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster family engagement, by having Title I meetings, family nights, and grade level informational meetings.
- 10. <u>Athlos Academy of Jefferson Parish</u> will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by encouraging staff to attend parental involvement workshops and conferences, and site staff development.
