PARENT INVOLVEMENT POLICY 2023-2024

PART I. GENERAL EXPECTATIONS

Athlos Academy of Jefferson Parish agrees to implement the following statutory requirements:

- Consistent with section 1118, the school will work to ensure that the required school level family engagement policies meet the requirements of section 1118 of the ESEA, and each include, as a component, a school-parent compact consistent with section 1118(d) of the ESEA.
- Schools will notify parents of the policy in an understandable and uniform format and, to the extent practicable, in a language the parents can understand. The policy will be made available to the local community and updated periodically to meet the changing needs of parents and the school.

1. **Athlos Academy of Jefferson Parish** will take the following actions to involve parents in the joint development of its school family engagement plan under section 1118 of the ESEA:

3. **Athlos Academy of Jefferson Parish** will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A

requirements and the right of parents to be involved in Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional family engagement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting, and will encourage them to attend, by through the automated communication system, the school's website, and through written notices and school newsletters.

4. **Athlos Academy of Jefferson Parish** will provide parents of participating children information in a timely ut Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by holding annual Title I parent meetings, parent/teacher conferences, grade level informational meetings, and family nights.
5. **Athlos Academy of Jefferson Parish** will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by through meetings with the student's teacher which may include the Title I Coordinator, the principal, and other staff as appropriate.
6. **Athlos Academy of Jefferson Parish** will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by distributing standardized test reports along with student report cards.
7. **Athlos Academy of Jefferson Parish** will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by distributing the Notice to Parents: Teachers Who Aren't High Qualified letter.
8. **Athlos Academy of Jefferson Parish** will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --
 - the state's academic content standards,
 - the state's student academic achievement standards,
 - the state and local academic assessments including alternate assessments,
 - the requirements of Part A,
 - how to monitor their child's progress, and
 - how to work with educators:

Parents will receive training and necessary information on the topics above through PTO meetings, grade level informational meetings on content standards and standardized tests, and school/district sponsored trainings and workshops.

9. **Athlos Academy of Jefferson Parish** will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster family engagement, by having Title I meetings, family nights, and grade level informational meetings.
10. **Athlos Academy of Jefferson Parish** will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by encouraging staff to attend parental involvement workshops and conferences, and site staff development.
11. **Athlos Academy of Jefferson Parish** will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand. Upon identification of parental need for information in another language or in another format, the school will take steps to ensure that the parent request is fulfilled.


